The authors of Chapter 1 have responded positively to the various comments on the SOD. In particular, the cross-referencing with WG1 to ensure consistency has been addressed and considerable efforts have gone into clarifying the section of the chapter on joint attribution, which attracted number of comments from referees.

In general I am happy that the comments have been addressed but there are a number of points listed below that should be clarified before this document becomes public.

p59-69 References to NA, A and TR. It is not clear what these mean. I presume that A is addressed and TR is text rewritten. Is NA not accepted and if not, why were the comments not accepted. These comments need to be filled out before this document becomes public.

E-1-412/414 These indicate queries and not that the comments have been dealt with.

E-1-442, 446, 460 It states here that references can be added under the editor's discretion. Who is the editor? The CLASs? We need to know whether the references have been added.

E-1-457 It is not clear how the statement has been addressed in the text.

E-1-466 and others. It states here that checks should be made with the original authors. We need to know in all such cases whether checks have been made with the original authors.

E-1-483 Lake Baikal is not in Europe (Table 1.6). It is in Asia.

E-1-603 Were these references followed up?

P103-104. There are several places here where it says that references have not been added because of space and do not introduce new facts. Perhaps this is the case but I would like to know whether any of these references make the point better and whether any of them would help improve the regional balance.

E-1-639 It is not clear whether this has been addressed

E-1-706/7 and in several other places on 0117/118. There are several statements indicating 'will do'. We need to know that these have been actioned.

E-1-708 Has this been discussed with CLA and has action been taken.

E-1-756 The action taken is unclear.

The authors of Chapter 1 have responded positively to the various comments on the SOD. In particular, the cross-referencing with WG1 to ensure consistency has been addressed and considerable efforts have gone into clarifying the section of the chapter on joint attribution, which attracted number of comments from referees.

In general I am happy that the comments have been addressed but there are a number of points listed below that should be clarified before this document becomes public.

p59-69 References to NA, A and TR. It is not clear what these mean. I presume that A is addressed and TR is text rewritten. Is NA not accepted and if not, why were the comments not accepted. These comments need to be filled out before this document becomes public.

Chapter One Answer: The following abbreviations were often used by Chunzhen Lui in the hydrology section. A: Addressed NA: Not applicable TR: Text removed NA did not mean Not Accepted but No Applicable.

E-1-412/414 These indicate queries and not that the comments have been dealt with.

*E-1-412:* The authors looked for published papers on observed coastal changes in the Netherlands, but did find any. The impacts there are very confounded by other driving forces.

*E-414* Authors looked for published citation with this information but couldn't find one. The reviewer needs to supply a published paper for consideration.

E-1-442, 446, 460 It states here that references can be added under the editor's discretion. Who is the editor? The CLASs? We need to know whether the references have been added.

*E-1-442: Martin Edwards, our Marine Biological Systems CA, felt that this satellite study was over a too short time-period to provide evidence of climate change but left the final decision up to the CLA, who sided with Martin Edwards, and the reference wasn't added.* 

*E-1-446:* Again, Martin Edwards felt this change was unnecessary, but left the final decision up the CLA, who agreed with the more specific "off the coast southern Californian coast."

E-1-460: The CLA agreed with Martin Edward and saw no need to include this older reference.

E-1-457 It is not clear how the statement has been addressed in the text. *The statement suggested by the reviewer (but rejected by Martin Edwards) was not brought forward the SPM*.

E-1-466 and others. It states here that checks should be made with the original authors. We need to know in all such cases whether checks have been made with the original authors.

The author was contacted and he gave permission for the figure to be used. The legend has been rewritten, in accordance with the paper the figure was taken from.

E-1-483 Lake Baikal is not in Europe (Table 1.6). It is in Asia.

We will change text of Table 1.3 to give the location of Lake Baikal as Russia and we will add the Shimaraev and Domysheva 2004 reference when we receive the Final Government Reviews.

E-1-603 Were these references followed up?

We looked for these references, but the reviewer did not supply enough information for us to find these exact references. However, we do have more recent material from authors with the same names, who we believe may be the same authors.

P103-104. There are several places here where it says that references have not been added because of space and do not introduce new facts. Perhaps this is the case but I would like to know whether any of these references make the point better and whether any of them would help improve the regional balance.

Both the Amazon and Canada are covered in our chapter, so including these references is not necessary for improved regional balance.

E-1-639 It is not clear whether this has been addressed

Text of entire section, including Summary was rewritten.

E-1-706/7 and in several other places on 0117/118. There are several statements indicating 'will do'. We need to know that these have been actioned.

The Contributing Author did what he said he would do. "Will" deleted from comments.

E-1-708 Has this been discussed with CLA and has action been taken.

Addressed earlier.

E-1-756 The action taken is unclear.

Energy and tourism selected because they are key socio-economic issues; a section on regional adaptation has been added in the FGD as well. The suggested references were checked, but neither of them is directly related to the topic of Section 1.3.9, and therefore were not included. The first one is about a survey of 600 Alberta households on knowledge, attitudes and behaviours related to climate change. The Second one is about the development of a socio-cognitive Model of Private Proactive Adaptation to Climate Change (MPPACC) and its application to two case studies.

- c) Several prominent experts, Trenberth (E- 161, 188, 377, 378) Bergstrom (382) Gerten (Potsdam) (386), Raga (384) think that too strong an emphasis is placed on  $CO_2$  direct influences on runoff without enough of the counter-arguments published and unpublished especially in last paragraph of 3.4.1
- d) A number of comments from ISDR mostly about disaster loss reduction measures for adaptation not accepted. E-607, 617, 633, 639, 669,

#### BOTH GOVERNMENT AND EXPERT COMMENTS

- a) 3.57 Late Argentina and 3-388 Canziani - there is no reference to chapter 13 in the groundwater section 3.4.2.
- b) 3-120 U.S.A. and 3-402 Mote - the issue of increased groundwater recharge in SW USA and its implications are questioned. (Comparing Fig. 3.4 and 3.5, it appears that more recharge is projected where annual runoff declines?)
- c) E3-2, 80, 81, 250, 272, 292, 293 and Ireland G3-11: Trenberth asks for greater attention to increased potential evaportranspiration. (Section 3.3.1 still implies precipitation is most important in all basins but for large lake basins, it is evaporation that is critical, making climate models more useful in those basins.)

### COMMENTS ON THE CHAPTER 6 FINAL GOVERNMENT DRAFT (FGD)

### **BY REVIEW-EDITOR J. DRONKERS**

#### **Previous Chapter 6 drafts**

The first draft of Chapter 6 was heavily commented by external expert reviewers. The writing team has spent great efforts to digest and implement these comments. The result was a greatly improved second order draft.

#### Expert comments on the second order draft

The expert comments were much less severe and much less in number than for the first order draft. Apparently many experts considered that their comments on the first order draft had been implemented in a satisfactory way. Most of the comments were suggestions for further improvement and additions, often on minor points. Only few expert comments had a controversial character.

#### Government comments in the second order draft

The executive summary was criticised, both for the wording and for the content. Several reviewers deemed insufficient the underpinning of some statements and the consistency with the text. Other points of critics raised by several reviewers pertained to the lack of regional specificity and to insufficient cross-referencing among chapters.

#### **Implementation of the comments**

Some major comments were discussed by email before the Cape Town meeting; remaining important comments were discussed during this meeting. Most time was spent on improving the executive summary.

#### **The Final Government Draft**

The executive summary has been completely rewritten in response to the reviewers' comments. The summary has not only been reformulated, to bring out more clearly the major policy relevant findings, but it has also been rendered fully consistent with evidence from the literature discussed in the body text. Many sections have been further improved thanks to the review comments and references to other chapters have been added. The global scope of the chapter precludes dealing with all specific regional and local climate impacts on coastal zones; however, examples referring to specific local settings are cited throughout the report. For this, a considerable amount of literature has been processed. To my opinion the final government draft is a well-balanced chapter reflecting the present state of knowledge agreed by a broad community of coastal experts in the world.

#### Concerns

- Review comments were received from only a fairly limited number of countries, in spite of the serious impacts of climate change on coastal zones

- I have not checked whether statements on coastal impacts in other chapters are consistent with chapter 6



### **Comments from Ivan Nijs**

### 1. General

The SOD of CH12 was in my opinion already well underway to reach the standards of IPCC and has further improved since. The quality of the chapter is now very high. The authors have enhanced precision concerning the scenarios used in cited studies, as well as their time horizon, up to the extent that including further detail would go at the cost of readability. Short-term forecasts (2020-2050) are now much better represented. The very recent literature has been included. Linguistic expression of uncertainty now generally follows IPCC guidelines. I am not sure though that the use of "will" in the main text always corresponds with virtual certainty, and I propose to do a final check on this. Some paragraphs still read like lists, but the problem has been greatly reduced, and in some cases this is hard to avoid. The ES now much better reflects the diversity of impacts, but adaptation remains less represented than impacts (main text is ok on this point).

Impact on biodiversity has been expanded to include more groups of organisms. Energy has received a more prominent place as justified by the energy crisis, and health is now also better covered. Positive effects are highlighted a bit more, which will avoid criticism of not being impartial. Text parts that received much criticism have been carefully reviewed (in particular: northward moving of forest into tundra biome, windiness changes, less or more frost damage in spring, biodiversity impacts, THC). Still few cost estimates are given, which may reflect availability. Among the phenomena that still receive little explicit attention are thresholds for impact, although this information is provided indirectly in cases where multiple time slices are specified. The lack of integrated assessments of impacts reflects the paucity of available studies and is mentioned in table 12.6.

### 2. Appraisal of how the comments were addressed

In almost all cases the comments have been carefully considered and appropriate action was taken. I only have the following items left:

### EXPERT COMMENTS

12.Z4: novelties since and contradictions with TAR are not really addressed other than (very briefly) in the ES, and even here TAR is mentioned only once. There is a section about TAR but it is left up to the reader to distinguish from the wealth of information in CH12 what are the key novelties or contradictions relative to this section on TAR. People don't want to spend time reading what they already know. As a example, colleagues in my department who heared that I was acting as RE, have all asked me the same question: what is new? The chapter would benefit from inserting here and there phrases like "opposite to the TAR" or "confirming the uncertain estimates at the time of TAR", etc. This can easily be done on say 10 or 20 critical locations, without having to change the existing text.

12.Z9: stabilisation scenarios are mentioned, say the authors, but I could not find the word stabilization anywhere.

12.S.8: section 12.4.8.2 on transport is conspicuous for not giving quantitative data (in contrast with the preceding section on energy); section 12.5.8 still has a very vague paragraph on adaptation of transport. 12.S12: I could not find the current numbers.





E-12-301: I do not know if there is much information available on climate warming effects on yield quality, but data on elevated CO2 effects on yield quality certainly exist. Elevated CO2 research in the USA in fact started with testing all major crops. Yield based on vegetative plant parts should in any case be affected by elevated CO2, as the latter generally reduces leaf nitrogen content on a mass basis.

E-12-395: many readers will be highly interested in guidelines on where new reserves (or expansion of old ones) should be located geographically in Europe, to be most efficient. If there is controversy on whether it should be the nortern or southern edge, please mention the controversy, in order to stimulate research. The matter is too urgent to wait until the next report.

E-12-454: Does *relative to the 'pre-industrial' climate* mean that compensation by warming itself is not included in the impact of shutdown? If so, I expect that readers will find this strange, because shutdown is a consequence of warming, so it does not seem to make sense to give expectations on the impact of shutdown alone, without the coinciding counteractive effect of its cause (i.e. warming). I guess the reason for presenting it like this, is that the outcome will vary depending on how much the climate has already changed when shutdown occurs. It will probably become clear if you explain the latter to the reader. E-12-481: (c) and (d) seem valid comments. It says "Table will be changed" but it was not for these items.

## GOVERNMENT COMMENTS

G-12-24 and G-12-116 It should be indicated at the beginning of the impact section that impacts are in the absence of adaptation measures. This is mentioned at the beginning of the ES but it is not clear whether it applies only to the ES or also to the impact section. Otherwise confusion may arise, see for example 17/37, where a decline in grassland area is predicted, vs. 28/2 suggesting to increase grassland area as an adaptation. I derive that this adaptation was not in the prediction on 17/37.

G-12-197: please carefully reconsider the option of irrigating current (!) dryland pastures.

G-12-235: table 12.4 is about impact; why is it in the sustainable development section?

G-12-237 34/10: transparency of criteria is needed, e.g. why are "tree line upward shift" and "northward/inland shift of tree species" in blue? They seem to imply negative effects on mountain/arctic tundra. Idem for northward migration of marine biota: why is this positive? Are the two blue arrows for Marine fisheries correct for North?

## 3. Other comments on content

The most critical ones are underlined.

4/16: not clear how nitrate leaching restrictions are related to the climate story (for other sectors, the background drivers (the D in the DPSIR scheme) are not mentioned either).

6/3: 12.2.1: are there no studies on observed changes in storminess? Since this comes back later in the predictions so it has no counterpart here.

6/44: what exactly is implied by the statement that Russia has greater oil reserves than OECD? 11/23: shouldn't 12.3.2 also contain trends in fossil fuel use?

15/17-19: not clear from this part how climate warming intensifies coastal and marine eutrophication.

15/21: shouldn't 12.4.3 mention CO2 effects, even if little is known?

17/39: "Grasslands are expected to decrease in area by the end this century": give reason so the reader can understand?

<u>18/42: the effect of elevated CO2 on plants is not mentioned at all (does species-specific stimulation generaly reduce or increase plant diversity?). I suggest to add this to the research gaps in table 12.6, as it is a major uncertainty in climate envelope modelling.</u>

26/28: contrary to the previous section, 12.5.2 does not give a single concrete adaptation measure, in spite of the first line stating that strategies are well documented.

27/50: shouldn't this specify where in Europe (probably not an option in the south)

28/40: you may want to add that this involves a risk of biological invasion!

29/48-30/1: this is mitigation of climate change, not adaptation to it, so this section does not belong here: reducing emissions by saving energy will mitigate all impacts, not just those on the energy and transport sector. There is confusion here between impact ON the energy sector, and how the energy sector could contribute to mitigating climate change.

32/43: are there no probability estimates for "any slowing in circulation before then"? Since there are for shutdown. Without probability estimates for slowing down, the reader is extensively informed about the consequences of an event of which the likelihood is not given.

33/5-6: "Results suggest that the repercussions for socio-economic factors are likely to be less severe than formerly might have been expected." This suggests that the consequences will not be so bad, while there are some very serious ones listed in Table 12.3 such as "Movement of populations to S. Europe and shift in the centre of economic gravity". I deduce that the earlier expectations were even more extreme, but the former sentence does not state that they were. Please consider rephrasing.

I have caveated my acceptance as indicated because I believe that in parts of the chapter, the balance and coverage of issues remains short of the what would be desirable in the IPCC, though this is as the authors note partly due to inadequacies of the underlying literature. My co-review editor, Uriel Safriel, has indicated a number of specific review comments on which responses were not as complete as would be desirable; I share his observations on this.

I also share Uriel's view that the Chapter has improved greatly since the Second Order Draft and the authors are to be commended for this additional effort.

IN my judgement, parts of the chapter still reflect early problems of a rather slanted approach to literature cited, inadequate cross-referencing and consistency with other chapters (notable 17, 19 and 20: the latter is significantly referenced but not fully "integrated" in the Chapter 18 discussion). In section 18.4 I think there remains a tendency to place too much emphasis upon a limited set of model based results.





I have accepted the authors implementation of the Review process because a number of these limitations are lessened and/or more directly indicated and accepted by the authors, and where model results are emphasised (eg. in 18.4), due caveats have also been entered suggesting that the underlying literature is still very patchy and frankly inadequate to the task required. The result, a somewhat slanted starting point (in the view of many reviewers) now duly caveated, is acceptable, though disappointing compared to what might have been possible in terms of a fuller and more balanced and rounded assessment from the outset.

In addition, and importantly, I consider the Executive Summary to be a good and balanced statement of the state of knowledge; it avoids the difficulties associated with quantified model analyses largely by drawing qualitative not quantitative conclusions. Though disappointing, this is perhaps a wise reflection of the state of the literature.

I do flag one outstanding concern, but this largely falls outside the remit of Review Editors and thus does not constitute grounds for objection. The discussion of "damages avoided" in section 18.4.2 really seems to draw upon three quite disparate standpoints with little attempt at synthesis. To only slightly caricature, it cites some studies that suggest serious damages may occur at such low stabilisation levels (eg. 450ppm) as to be more or less unavoidable. In stark contrast appear to be conclusions cited from Tol and Yohe that most dangerous impacts could be avoided even at quite high stabilisation levels, such as 850ppm.

These two poles in turn are strikingly different from the box, which offers a more graduated analysis but is cross-referred to Working Group III, presumably drawing upon some more graduated literature. The net effect is a quite unsettling mix of perspectives, without even a single place in the IPCC where the literature and issues are fully worked out around this crucial question.

It is clearly too late to change this in the AR4 process. I would urge the IPCC to consider whether the Synthesis report could make progress by considering these three perspectives, and the underlying literatures, in a more integrated manner, albeit within its limited space and procedural requirements.

Whether or not this is possible (and I appreciate the constraints), I would urge the IPCC, after the dust on AR4 is settled, to give extensive consideration to the problem of integrating analysis across impacts, adaptation and mitigation, particularly those arising at the global level. Ever since the closing furores in 1995 around the Second Assessment Report Working Group III (which was explicitly mandated to address cross-cutting issues – not mitigation per se), I have argued that this is a fundamental problem given the architecture of the IPCC in the TAR and AR4, and that more considered thought should be given to this challenge. I had not expected the problems to be quite so starkly illustrated by the difficulties this chapter has experienced in striving to reach a fully integrated, rounded and consensual assessment of the state of knowledge.

## REVIEW EDITOR STATEMENT ON CHAPTER 19 OF WORKING GROUP II AR4 ADDITIONAL COMMENTS AND CAVEATS

I was present for almost all of the Lead Authors' consideration of Review Comments on Chapter 19 at both the Merida and Cape Town Lead Authors' Meetings and can confirm that, in my observation, the Coordinating Lead Authors and Lead Authors all took the process of response to Review Comments very seriously and did their best, through their point-by-point discussion, to identify fair and appropriate responses to every comment. While some Reviewers had gone to excessive lengths to draw attention to their own views or publications, the Lead Authors treated each comment on its merits and rarely showed (what would have been an entirely understandable) inclination to become dismissive of overly repetitive or overstated comments from particularly aggressive Reviewers.

It is important to note, in respect of Chapter 19, that the Chapter's heavy dependence on material from other Chapters (and from Working Group I) made it particularly difficult for the Lead Authors to produce an up-to-date draft for Government and Expert Review and it had to be expected that substantial rewriting would be needed after Cape Town to bring the Chapter into alignment with the rest of the Report, as well as to respond to the detailed Review Comments on the Chapter itself. It is therefore understandable that the 'Final Draft for Government Review' cannot be as comprehensively reconciled with the Review Comments on the previous draft as for some of the other chapters.

3 The above said, there are some specific problems with the Lead Authors' completed responses to review comments (and hence with the Final Draft for Government Review) which require me to record some small caveats to my answer (ie 'Yes') to each of the questions on the Pro Forma 'Statement by Review Editors' in respect of Chapter 19. They are as follows:

- (a) Traceability. I had expected that the Lead Authors' response in the 'Notes of the Writing Team' column would in most, if not all, cases identify where, in the revised text, the issue raised had been responded to. In fact, with a few commendable exceptions (eg 19.Z.15 (p 6), E-19-14 (p 114), G 19-218 (p 45), E 19.1 (p 15)), this is not done and it is extremely difficult to find where, in the revised text, the response is incorporated or implicit. While, as a Review Editor, I am happy to certify that the Lead Authors have responded fairly to the general sense of the majority of comments, I can not, in many cases, provide explicit certification in respect of the specifics.
- (b) Significant points not fully taken on board. In several places (eg E-19-9 (p 18), E-19-91, 92 (p 44)) where the balance of comments suggests an approach different from the Lead Authors' preferred approach and they have chosen to stick with their own preference, responses such as 'Unfortunately we cannot please everyone . . . ' do not really do justice to the points being made and give an arguably misleading justification of the basis on which they have rejected the Reviewer's proposals.
- (c) Misleading implications that comments have been taken on board. There are numerous places (eg G-19-86 (p 21), G-19-107 (p 22), G-19-111 (p 27), G-19-149 (p 34), G-19-166-169 (p 37)) where, by using words like 'yes', 'OK', 'Text Revised', 'Text revised to deal with many of these issues' etc, the Lead Authors imply that they have actually taken the Reviewers' points on board whereas, in fact,





they have either ignored them, deleted any relevant text where they might have been incorporated, or actually taken a different position in their revised text.

- (d) Uncompleted responses. There are several places where, in the 'Notes of the Writing Team' column, the Lead Authors have not gone back and tied off their final response. For example:
  - E-19-206 (p 74) 'Will address in text'
  - E-19-227 (p 78) 'Will check'
  - E-19-322 (p 92) 'Will look at'
  - E-19-3 (p 112) 'Review and will consult chapters'
  - G-19-156 (p 35) 'Will consider'
  - G-19-183 (p 39) 'Can consider'
  - G-19-207 (p 43) 'Looking for better reference if there is time'
- (e) Erroneous statements. There are some (but not many) places where it is stated that something will be done, or has been done, and it clearly hasn't, eg G-19-255 (p 53) where it states '19.4.4 will be changed to 19.5' but the change has not been made.

I should also draw attention to one particular point on which it is arguable that the Lead Authors have tried to give the impression of having responded to Review Comments but have subtly avoided doing so to the extent implied. In lines 18-19 of the Introdution (p 5 of the Final Draft) they leave ambiguous whether 'other judgements' are 'value judgements' or 'scientific judgements' ('other judgements informed by the state of scientific knowledge'); and then, while asserting (Notes of the Writing Team in response to G-19-22 (p 7)) that 'the key vulnerabilities in this chapter are intended to provide information useful to policy makers in making their DAI judgements, not to provide those judgements', the Lead Authors appear to build in quite a lot of value judgements and equate DAI with 'key vulnerabilities' in the later text (eg p 29, line1, p 30, line 35).

5 In summary, though, I believe the Lead Authors of Chapter 19 are to be commended on the fair and conscientious way they handled the extensive Expert and Government Review Comments on their successive drafts.
